  - a) To any child for lack of age proof; or
  - b) If such admission is sought subsequent to the extended period, prescribed period
  - c) On the ground of religion, caste or race, place of birth or any or these reasons.
- 7. The school shall ensure that:-
  - a) no child admitted, shall be held back in any class or expelled from school till the completion of elementary Education in a school;
  - b) no child shall be subjected to physical punishment or mental harassment;
  - c) no child is required to pass any board examination till the completion or elementary
  - d) every child completing elementary education shall be awarded a certificate as laid down
  - e) inclusion of students with disabilities/special needs as per the provisions of the Act;
  - f) the teachers are recruited with minimum qualifications, as laid under sub-section (1) of section 23/ provided that the existing teachers who, at the time of commencement of the Act, do not posses the minimum qualification, shall acquire such qualifications with in a period of 5 years from the date of commencement of the Act.
